In 2008, Kerry took the helm of the newly established Indian River Community Foundation in Vero Beach, Florida as Executive Director. Kerry guided the organization as it expanded the Board of Directors from five to 15 members and developed its infrastructure, policies and procedures. Under her leadership, the fledgling organization grew its philanthropic assets from zero to \$30 million as of December 2014.

Prior to joining the Indian River Community Foundation, Kerry was Principle of The Bartlett Group, a consultant to nonprofit organizations on strategic philanthropy, fund development and Board governance. Kerry's nonprofit career started with an 11 year stint Campaign and Communications Director for the United Way of Indian River County.
